निशान गेट के बाहर दिख रहे थे और फ्लैट के अंदर पंखा चलने की आवाज आ रही थी जिस पर सचनाकर्ता ने अपने लडके के मोबाइल से मामले की पुलिस कंट्रोल रूम में 100 नंबर पर दी। फर्स पर खून फैला हुआ था। ऐसा प्रतीत हो रहा था किसी ने फ्लैट के अंदर घुस कर मृतक की चाक से कई वार कर हत्या की है और बाहर से ताला लगाकर भाग गया। संपूर्ण विवेचना उपरान्त अभियोग पत्र न्यायालय में पेश किया गया, जिस पर से आरोपी अंकुर को उक्त सजा सुनाई गई।

WRESTLERS HALT IMMERSION...

However, after spending an hour and 45 minutes, they returned after several khap and political leaders urged them not to take such an extreme step. As the deadline for the immersion of the medals drew closer, senior farmer leaders Sham Singh Malik and Naresh Tikait sought five days' time from the grapplers to resolve the issue.

'The khap leaders put their turbans before us and said 'do not lose hope'. Keep the dignity of the turban and return. So we decided to wait," said wrestler Jitender Kinha, who has been a part of the protesting group. There were chaotic scenes at the Har ki Pauri as khap and farmer leaders broke the human chain of supporters to reach out to the grapplers, even as thousands of devotees, who had gathered on the occasion of Ganga Dussehra, looked baffled as commotion reigned supreme. The wrestlers left without speaking with the media. Several other khap leaders and Punjab Chief Minister Bhagwant Mann also came out in support of the wrestlers but urged them to show restrain. "The wrestlers have said they will immerse their medals in Ganga river. We request them that these medals are the result of their hardwork, sacrifices of their families and support from society... they should not take this step.

"It is unfortunate that those who represented the nation in top international tournaments that they are forced to take such decisions. The government should have some shame and give justice to them," Khap leader Balwant Nambardar said.

'Allegations serious'...

Sisodia was arrested by the CBI on February 26. The high court said the allegations against him are very serious in nature. Will return awards...

In the memorandum, the sportspersons questioned the central security forces in controlling the violence despite "Kuki terrorists challenging the integrity of Manipur' by killing people and burning houses. "We condemn such attacks on unarmed civilians, specially in the peripheral areas of the valley districts," they added. The sportspersons demanded revocation of the Suspension of Operation (SoO) agreement with Kuki militant groups, restoration of peace and normalcy at the earliest and protection of unity and integrity of Manipur. "The demand to disintegrate Manipur is not acceptable under any circumstances,' the memorandum said and demanded deportation of all illegal immigrants. The sports personalities also urged the government to lift the blockade on NH 2 as it has led to skyrocketing of prices of essential com-

HM announces Rs 10 lakh for victims' families

Amit Shah, who had already held a half a dozen meetings since his arrival in violence-hit Manipur on Monday night, on Tuesday visited Churachandpur, one of the districts severely affected by the ethnic violence that ravaged the state since May 3, leaving at least 75 dead and over 300 injured. According to a senior Manipur government official, during a meeting between the Home Minister and state council of ministers headed by the Chief Minister, it was decided to give compensation of Rs 10 lakh each to those who died during the ethnic violence.

A government job would also be provided to a kin of the family whose members were killed in the violence. The compensation amount would be equally borne by the Centre and the

state. Officials said that in the tribal-dominated Churachandpur, Shah held meetings with various Civil Organisations (CSOs), influential tribal leaders and local security and civil administrations officials. "This crucial engagement aims to study the

"What use is a life lived compromising on your self-respect," a letter in Hindi, tweeted by the top athletes who have been leading the protests since earlier this year, said. A letter explained they had wondered whom to return the medals to before deciding to immerse them in the Ganges. "The President, who is a woman herself, sat barely two kilometres away and watched when they were roughened up by men in khaki. She didn't say anything," the letter said, on why they didn't feel like returning the medals to her. The wrestlers also accused the Prime Minister of not asking about them "even once". "Instead, our oppressor (Brij Bhushan Singh) was at the inauguration of the new Parliament building in dazzling white clothes, getting pictures clicked. This white was stinging us as if it was saying Tam the system'," the letter, tweeted by the top grapplers further said. "We don't need these medals anymore because this system feeds on its own propaganda by hanging them around our necks and putting a mask," the letter said. "They then exploit us, and put us in jail if we protest," it added. The wrestlers said they have chosen the Ganga River as it is "our mother". Just as they consider Ganga sacred, the medals too have a certain sanctity. And the holy river is the appropriate resting place for them, it was reasoned. The letter began by accusing the police of brutally cracking down on their "peaceful" protest march, ransacking their protest site, and filing FIRs in serious cases against them. 'The police and the system are treating us as criminals while the harasser openly attacks us in public meetings," the letter said.

The Delhi Police had accused the protesting wrestlers of breaching the barricades and rioting, a charge that has been refuted. Earlier this month, the ace wrestlers alleged that a group of drunk Delhi Police personnel targeted them when they wanted to bring in mattresses to sleep on a rainy day. The policemen beat them up and abused the women wrestlers, they had said. Several grapplers were hit on the

head and two of them sustained injuries. One person had to be taken to the hospital.

DIGNITY OF WOMEN...

This is an affront to all women of India.

It is not a political issue, but one which affects the dignity of all women," she observed. "The registration of the FIR appears to be only a formality. The central government is not at all serious about taking action under law against Brij Bhushan, who has a criminal record. We will not be silent spectators to this display of arrogance," she noted. Charge sheet filed in IIT...

Solanki's Instagram chat dates back to a few days before his suicide. The teen had confided to the person online that he was in a lot of trouble, that the nature of a close family member was not good and that was the reason he had purposely obtained admission to a college where he could be away from home. He said further that he was not able to study and unable to score too, because of which, he said, he was "again going into depression". He had sought guidance from the other person to improve his marks, the charge sheet said.

police had arrested Solanki's batchmate Arman Khatri and booked him for abetment to suicide, among other offences under the SC/ST Act. chargesheet claims Khatri had threatened Solanki with a paper cutter after a tiff over remarks the latter had made on his religion, because of which Solanki was frightened, which led to the act. It also mentions in his conversations with some students, Solanki had said he was afraid Khatri would harm him.

Khatri, an 18-year-old, secured bail earlier this month from the special court. While giving him relief, the court had said that there was nothing to show he had harassed Solanki on caste grounds.

Police have recorded the statements of 55 witnesses – 14 of whom are students - most of them who lived on the eighth floor of the hostel, where Solanki resided too. The chargesheet also contains the statements of seven professors of the institute. Their statements concerned Solanki's studies and his performance.

Some witnesses spoke about Darshan shivering when Arman threatened him and others trying to comfort him, the chargesheet said. Solanki had told some witnesses that Khatri was influential and would not spare him, the chargesheet claimed.
